The Rehabilitation center "Villa Ardeatina" is in Rome in Via Mentore Maggini n.51 (area Laurentina - Vigna Murata), and it is considered a genuine green oasis in the heart of Eur. The Structure can be reached by public transports Atac 721, 762, 765 and by the Subway B Laurentina from which Station Termini, Piramide and Viale Marconi-EUR are easily reachable.



Documents required to accept the rehabilitation services pursuant to Article 26

- ✓ Valid identity document
- ✓ Copy of clinical documentation (medical records, disability report, etc.)
- ✓ Multidimensional evaluation carried out by the ASL of residence (for the residential maintenance regime at home and for the extensive residential regime for patients coming from home)
- ✓ Request from the general practitioner or specialist doctor of a public ASL facility (for outpatient treatment)
- ✓ Direct request from the hospital for acute / post-acute patients or post-acute facilities (for the extensive residential regime).

EXTENSIVE MOTOR REHABILITATION AND MAINTENANCE (EX ART. 26)

Extensive rehabilitation is that complex assistance activity for patients who have passed the possible acute and immediate post-acute phase and who need interventions aimed at guaranteeing further functional recovery in a defined time.

Maintenance rehabilitation, on the other hand, is that activity aimed at maintaining residual abilities and therefore characterized by various pathologies of health rehabilitation interventions integrated with psycho-social activities.

The Regimes on which the service is divided are:

✓ **Extensive residential and maintenance regime (Hospitalization)**

The treatments are ensured by the interdisciplinary team in order to ensure coordinated and integrated performance during the 24 hours.

SHARING

For users in a residential maintenance regime, there is a share of the cost of a maximum of € 35.64 per day, to be paid by the Municipality or by the user.

✓ **Outpatient Regime**

The patient's access to the facility is envisaged for multidisciplinary rehabilitation activities.

The service is active from Monday to Friday from 8:00 to 18:30 and on Saturdays from 7:30 to 13:00.

✓ **Home-based regime**

The multidisciplinary rehabilitation activity is foreseen at the patient's home



PRIVATE OUTPATIENT SERVICES

Inside the structure it is possible to do rehabilitation services and specialist visits a payment from Monday to Saturday.
