In particular in the R.S.A. are provided:

- ❖ general medical, specialist and pharmaceutical services, paid by the S.S.R., under the conditions and methods provided for the generality of citizens, also through district and company services;
- ❖ nursing services;
- ❖ rehabilitation services;
- ❖ dietary advice and monitoring;
- ❖ personal help and guardianship assistance services;
- ❖ prosthetic, complete dental and podiatry services under the conditions and in the manner envisaged for the generality of citizens;
- ❖ hotel-type services including accommodation, food and general services related to the particular conditions of the guests;
- ❖ entertainment, employment and recreational activities for integration and connection with the family and social environment of origin;
- ❖ transport and accompaniment and possible assistance for the use of health services outside the R.S.A.;
- ❖ personal care services (barber, hairdresser and similar) at the request of the guests and at their own expense;
- ❖ religious and spiritual assistance by encouraging the presence of different religious assistants depending on the confession of the guests.
